I, **(Participant's Name)** _____ recognize that participation in the above described event/activity involves vigorous physical exertion and that I may sufferer temporary or permanent serious physical injury, including but not limited to sprains, fractures, brain or spinal damage, paralysis or even death while participating in the event/activity. With full knowledge of the above-referenced risks, and in consideration for being permitted to voluntarily participate in the event/activity identified above, I HEREBY AGREE NOT TO SUE AND TO DEFEND, INDEMNIFY, AND FOREVER RELEASE AND HOLD HARMLESS the City of Goodyear, its officers, employees, agents, and volunteers, individually and collectively, while acting in their official capacity; of, from and against any and all liability, damage, claims, suits, payments, judgments, demands, expenses, attorney's fees, defense costs, and/or actions, of any kind or nature, including fault or negligence, related to, arising out of, or alleged to arise out of directly or indirectly my participation for any purpose in the event/activity. In order to maintain a safe, educational and fun atmosphere for all RECREATION participants staff are responsible for consistently enforcing the established rules and regulations of RECREATION. When a violation of these rules occurs the first step of discipline is a verbal warning and re-direction of the program participant. If this is unsuccessful, the second step is a time out from activities and contact made with the parents. This may also be done in the form of a Discipline Ticket. The Recreation Leader on site will discuss the incident(s) with the parent and ask that they assist in reinforcing the following RECREATION site rules. Repeated incident or negative behaviors which put a child at risk for injury may warrant a suspension from RECREATION. Suspension will be authorized by the Recreation Coordinator and explained to the parent by the Recreation Leader.

Please read over the following RECREATION Rules with your child and be sure that he/she has a clear understanding of their position behavioral expectations while participating in RECREATION activities.

Rules

- No profanity or name-calling towards staff or other participants.
- Listen to and follow directions given by staff at all times.
- No destruction of site equipment or games. Report any problems right away to staff.
- No physical contact with other participants or staff members is allowed.
- No running inside the building.
- No sitting on tabletops.
- No horse playing, shoving, pushing, wrestling, scratching, or biting staff or participants.
- No hanging out in the restrooms.
- No use of outdoor equipment inside the building. (Ex: basketball used in the gym or outside)
- No food or drinks allowed around or near game tables. (Ex: pool table, board games, etc)
- No stealing or destroying the property of staff, other participants or the site.
- No gang colors or gang attire allowed at RECREATION.
- No littering inside or outside the RECREATION area.
- Always listen when staff or other participate are speaking. No talking out of turn.
- No wandering away from supervised activities while signed into the program.
- No use of personal equipment during RECREATION :(Ex: scooters, bikes, hand held video games)

I have discussed the RECREATION rules with my child and understand that these rules must be followed to provide a safe, healthy and enriching program for all participants.

CODE OF CONDUCT**

The following Code of Conduct penalties will be implemented when Progressive Discipline steps have failed or the severity of the incident warrants its use. This Code will be enforced during all program activities within summer recreation. All rules will be consistently enforced.

STATEMENT OF PURPOSE:

To provide a safe, fun and educational program where children are expected to show self-discipline, respect for others and good choices. Emphasis is placed on each participant taking responsibility for his/her own behavior.

CITY OF GOODYEAR CODE OF CONDUCT: (Before the following code is implemented in items #1 and #2, staff will follow the Progressive Steps of Discipline.)

- 1) **No Individual Shall** at any time lay a hand upon, shove, strike or threaten to strike ant other individual.
 - a. **Minimum Penalty:** 1 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.
 - b. **Maximum Penalty:** 3 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.

- 2) **No Individual Shall** use profane, obscene, or vulgar language towards any other individual.
 - a. **Minimum Penalty:** Discipline Ticket sent home and the parents contacted.
 - b. **Maximum Penalty:** 1 Day suspension, a Discipline Ticket and parents contacted.

- 3) **No Individual Shall** be guilty of stealing from another individual, the site or any facility.
 - a. **Minimum Penalty:** 1 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.
 - b. **Maximum Penalty:** 3 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.

- 4) **No Individual Shall** be guilty of a physical attack as an aggressor upon any other individual.
 - a. **Minimum Penalty:** 1 day suspension, Discipline Ticket sent home, the parent contacted and possible Police involvement.
 - b. **Maximum Penalty:** 3 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.

- 5) **No Individual Shall** be guilty of vandalism, defacing of facility, or personal property.
 - a. **Minimum Penalty:** 1 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.
 - b. **Maximum Penalty:** 3 day suspension, a Discipline Ticket sent home, the parent contacted and possible Police involvement.

- 6) **No Individual Shall** be guilty of any illegal or criminal behavior. Police contact will be made.
 - a. **Penalty:** The individual will be suspended until the staff can review the incident.

- 7) **No Individual shall violate posted site rules.**
 - a. **Penalty: For every 3 disciplinary tickets there is a 1 day suspension, additional 3 disciplinary tickets = 2 day suspension, etc.**

The severity of any infraction will determine the penalty. Penalties can fall between the minimum and maximum. An individual receiving 3 Discipline Tickets during the summer will be required to attend a meeting with the staff and their parents.
